- No address of seniors
 - o Future, comfort, health, Sr. Dept.
- Needed back senior population growing rapidly
- Hospitals send seniors to
 - o Suburban nursing homes how to keep seniors in Detroit?
 - o No assisted living in Detroit
- Include rationale for including these things in charter, for implementers and future charter commissions
- Exclude ability of elected officials to remove Sr. Dept. from existence
- Sr. Dept. access to all city departments with city services, e.g., transportation sr. citizens, grant \$\$ does it go to DAAA, or to various service departments/mayor's office?
- Mayoral/Executive Branch involvement in Sr. Dept. to ensure results
- One person a department head accountable for delivery of city services to seniors
- Communication / referrals between service departments/agencies to provide effective services to seniors (housing, transportation, clinics, etc.)
- Income guidelines > priority to seniors re: NOF; lower/exempt taxes for seniors vision care, foot care, walkers, inhome care bonded staff
- Sr. services create jobs, e.g., snow removal
- Advocate/Ombudsman to provide info re: available services, benefits. Keep up-to-date on this; able to act in legal
 arena on behalf of seniors
- Sr. Council needed to advise on sr. needs, issues
- Wellness Centers, Health Care, Counseling, Referrals to other available sr. services, preventive services
- Somehow create "bridges" between youth adults seniors, e.g., seniors into schools, organize youth to protect seniors
- Part of CDC's: include seniors and youth groups

- Senior calls to DPD should be priority calls
- Eating clubs in neighborhoods
- Seniors involved in farming
- Schools needed to serve more than students, i.e. seniors
- Utilize media (Public TV) to communicate senior resources
 - All recommendations coming to Charter Commission should be documented and referred to appropriate officials and archived.
 - two senior information fairs
 - get school children to perform at conventions
 - no Sunday sessions
 - children, youth and seniors mentioned in charter mission statement

ANALYSIS: On April 12, 2006 Mayor Kilpatrick filed amendments to the Executive Organization Plan required by §7-102 (Assignment of Authorized Functions) of the Charter, which were approved by the City Council resolution and effective July 7, 2006. Amendment No. 3 and Item No. 5 of Amendment No. 6 transferred to the Office of the Mayor (Neighborhood City Halls) the functions of the former Department of Senior Citizens. These functions related to senior citizens advocacy, information and referral activities.
